I. Scope of Work

- i. Kindly go through the below points carefully.
- ii. BFSL invites Proposals for engagement of Insurance Brokers/consultants with its Policy' to be taken by the BFSL.
- iii. Only well established and reputed Insurance Broking/Consulting Firms which are Registered /Issued License by Insurance Regulatory and Development Authority (IRDA) under "Composite" License category are eligible for engagement under contract.
- iv. At any time prior to deadline for submission of proposal, BFSL for any reason, modify the RFP. The prospective respondents having received the RFP shall be notified of the amendments and such amendments shall be binding on them.
- v. BFSL reserves the right to accept any or reject any or all the proposals in whole or part without assigning any reasons.
- vi. BFSL intends to select one (1) Insurance Broking/Consulting Firm by issue of Request for Quotation , under contract.
- vii. During pre qualification and evaluation of the Proposals, the BFSL may, at its discretion, ask respondents for clarifications on their proposal. The respondents are required to respond within the time frame prescribed by the BFSL.
- viii. Documents needs to be submitted in online via email at rfp@bobfinancial.com in a sealed envelope. Only detailed complete proposals in the form indicated, received prior to the closing time and date of the proposals shall be taken as valid.
- ix. Respondents are not permitted to modify, substitute, or withdraw Proposals after its submission.
- x. The documents may be submitted along with the covering letter about the documents, along with the information/documents indicated in the Annex and the declaration, signed by the authorized signatory with Seal of the Company. All pages are required to be signed.
- xi. No cost will be borne by the BFSL towards preparation and submission of the proposals.

- iii. Failed to provide related clarifications, when sought;
- iv. Declared ineligible by the Government of India/State/UT Government for corrupt and fraudulent practices or blacklisted.
- v. Less Technical score.

IV. TERMS AND AWARD OF WORK:

8.1 The duration of Empanelment of proposed Broker will be for a period of 3 years from

signing of Agreement & PO.BFSL can extend the contract further for 2 years on discretion of BFSL. However, the BFSL reserves the right to cancel or extend the validity period of empanelment.
